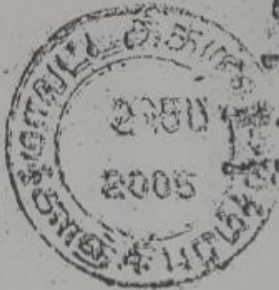

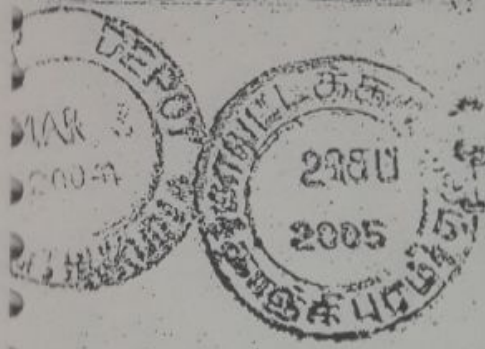
II. CREATION OF THE TRUST :

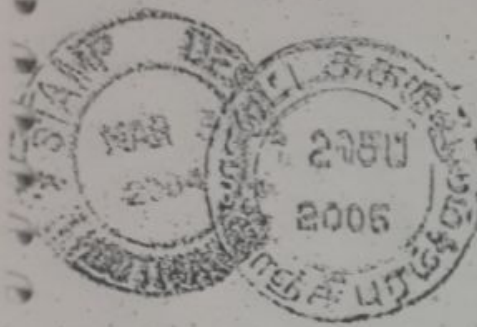

To render assistance for marriages of the deserving poor, irrespective of caste, creed or religion.

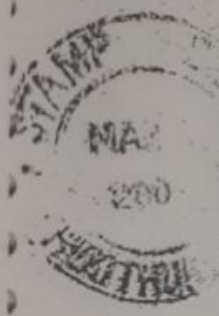

The income and funds of the trust shall be solely utilised towards fulfillment of the object of the Trust and no portion of it shall be utilised for the payment or benefits of the trustees of the trust by way of Profit, Interest, Dividend etc.,

The surplus funds of the Trust shall be invested in accordance with the provision 13[1], 13[iii] read with Section 11 of the Income Tax Act.

To sell, Mortgage, grant on lease, hire or otherwise alternate all properties of the Trust. No property of the Trust shall be alternated without the prior approval of the Director of Income Tax, Chennai.

The income of the trust shall not be applied for any religious purposes or given to religious institutions not more than 5 % of such income.

The financial year of the Trust shall be from 1st April to 31st March. The accounts of the Trust for each financial year will be audited by a duly

qualified auditor appointed by the Trustees as prescribed in section 16 of the Act.

There is no movable or immovable properties stand in the name of the Trust as on the date of Registration.

VI. MANAGING TRUSTEE OF THE TRUST :

a) Mr.K.RANGANATHAN shall be the first Chairman and the Managing Trustee of the Trust for life. The first Chairman and Managing Trustee so desires, then he can nominate at any point of time any other person to act as the Managing Trustee, while he shall continue to be Chairman of the Trust.

The other Trustees of the Trust shall hold office for his life time.

The Trustees shall have power to co-opt additional Trustees or to remove them after such appointment of his passing necessary for the same.

VII. POWERS OF THE TRUSTEES :

The Trustees and the Managing Trustees as the case may be shall execute the objects of the trust and shall have the power to supply the whole or any part of the Trust Fund or properties, whether capital or income or towards payment of any expenditure of the Trust of for or towards all or any of the objects of the Trust namely :-

1. To acquire by purchase, grant, gift exchange, lease, hire or otherwise, lands, buildings, movable and properties of ever-other description.
2. To sell, mortgage, grant on lease, hire or otherwise alternate all properties of the Trust. No property of the Trust shall be alienated without the prior approval of the Director of Commissioner of income-tax (exemptions).
3. To enter into all contractors on behalf of the Trust and to rescind them.
4. To borrow money with or without security and to repay the same.
5. To open accounts in the name of the Trust with Bank or Banks and to operate the same.

6. To invest all funds of the Trust nor immediately required for the purpose of the Trust in such investments as may be permitted under section 11[5], read with section 13[1] [a] of the income tax act 1961.
7. To receive collect and enforce of all monies due to or payable to the Trust and grant necessary receipts and discharges therefore.
8. To appoint, terminate, suspend or otherwise deal with the staff employed for the administrations of the Trust.
9. To appear before courts, tribunals public officials etc.,
10. To produce and defend all suits and other legal proceedings.
11. To incur all necessary expenses in connection with the Trust and its management.
12. To accept contributions, donations, gift to, legacies or grants to the trust and from any persons and to hold the same upon trust and subject to the powers, provisions and stipulations contained in their DEED OF TRUST.
13. To organise and establish a printing press to print and to publish books, magazines, periodicals etc., of knowledge and to spread education only.
14. To invest the Trust fund in such in manner as required by law.
15. To construct new buildings or structure or re-build improve enlarge or add to all or any one more of the buildings or structures forming part of the Trust fund at any time.
16. To deposit, invest, withdraw, purchase, sell, mortgage redeem convert, consolidate, subdivide, renew or otherwise deal with the securities or other assets, movable and immovable properties owned by the Trust.

17. To receive gifts, purchase, sell mortgage assign, surrender lease and exchange the movable and immovable properties owned by the Trust.

18. To appoint local committees, adhoc-committees or other committees for any purpose as and when required consistent with the aims and objects of the Trust.

19. To co-opt members as the Board of Trustees as may deemed necessary. The Trust shall not carry on any business.

VIII. MINUTES, ACCOUNTS & AUDIT :

The Trustees shall maintain true and correct accounts of the Trust and a correct record of their deliberations and shall have the accounts duly audited by a qualified Chartered Accountant.

IX. POWER TO ALTER RULES & REGULATIONS :

The Trustees shall have full power and authority to make after and rescind rules and regulations for the management and administration of the Trust only with the previous approval from the Director of income-tax (exemptions), Chennai.

X. INCOME FOR THE TRUST :

The Trustees shall collect and recover the income of the Trust Fund and shall provide for all costs, charges and incidental expenses, including insurance premium, expenses for or ordinary repairs all other outgoing and expenses for the management and administration of the Trust. No part of the income of the Trust shall be distributed among the trustees by way of dividend, profit.

XI. APPLICATION OF INCOME AND TRUST FUND :

The Trustees shall after providing for the above mentioned payments and disbursements, apply and utilizes the net income or the corpus of the Trust Fund for the benefits of the citizens of India without any discrimination on the ground of religion, caste or creed or accumulate or put by other statutory notification thereof, after complying with the provisions of the income tax act 1961 or the whole or a portion thereof for the benefits of the Citizens of India in the manner above referred for the fulfillment of all or any or more for the above mentioned objects by such ways and means as the first Trustees or their successors in office may from time to time in their absolute and unfettered discretion determine.

XII. FOUNDER SETTLOR AND THEIR RELATIVES NOT TO BE BENEFITED :

Notwithstanding the power vested with the Trustees under the proceeding clause, no part of the income of the Trust shall ensure directly or indirectly for the benefits of the Founder-Settler or any person who make a substantial contribution to the Trust or any relatives of the Settler or the person who make a substantial contribution for the purpose of this clause, relative in relation to the settler or the persons who make a substantial contribution to the Trust shall mean, spouse, brother or sister or any lineal descendant of the brother or sister if the settler or such relative as any be prescribed by law from time to time.

XIII. REIMBURSEMENT OF EXPENSES MET BY THE TRUSTEES :

Nothing do mentioned in clause XIII & XIV here in above, shall apply to any remuneration, allowances, perquisites etc., paid or payable to any Trustees for the services rendered in any capacity other than of Trustees as such (like principal, professors, lecturers etc., in any college or institution

run by the Trust) and the Trustees may reimburse themselves or pay out of the Trustees Trust Fund all expenses which may be incurred by them in or about the execution of the Trust and powers of these presents. However, such sums shall not be more than the amount payable to others in the same profession.

XIV. REMUNERATION TO THE TRUSTEES :

The Trustees shall not be entitled to draw any remuneration from the trust. The trustees shall be liable to account respectively only for such monies as they may receive and if he or she they all to render true and correct amount of the sums, he / she or they shall be liable personally to account of such same how ever they are in not liable of for any involuntary losses or for any loss so suffered no due to their own willful acts.

XV. IRREVOCABILITY :

The Trust is irrevocable, however, the first Trustees at any time, in their discretion and for the better fulfillment the object of the Trust may dissolve the Trust and distribute the Funds and properties of the Trusts having similar object and enjoying 80-G exemption.

XVI. OFFICE OF THE TRUST :

The principal office of the Trust for the time being, shall be situated at No.82, Tiruvallur Road, Uthukottai-602 026. The Trustees are at liberty to transfer the principal office of the Trust to any other place at their own discretion.

XVII. ACCEPTANCE OF THE TRUSTEES :

All amendments to this Trust Deed shall be made only with the prior approval of the Director of income tax (exemptions), Chennai.
